

# **Big Y NESN All-Access Sweepstakes Official Rules**

## **NO PURCHASE NECESSARY TO ENTER OR WIN**

### **ELIGIBILITY**

Big Y NESN All-Access Sweepstakes (The “Sweepstakes”) is open to all legal residents of the United States who reside in Connecticut, Massachusetts, New Hampshire, Rhode Island, or Vermont, who are 18 years of age or older as of Thursday, May 2, 2019. One (1) winner will be determined in a random drawing on or about Monday, June 3, 2019 from all eligible entries received. Odds of winning depend upon the number of eligible entries received. Decisions of Sponsor regarding the Sweepstakes are final.
